- The intent of EHAC guidelines is to be flexible to the extent that they enhance program quality and are consistent with regional needs, at the same time to meet the minimum criteria for graduates of an EHAC accredited program.

EHAC accreditation signifies:

## Accreditation Benefits:

EHAC is a nationally respected partner for academic environmental health programs. EHAC serves as a non-profit organization that accredits high quality undergraduate and graduate programs. Student and graduate benefits of accreditation include:

### Undergraduate Student Benefits of Attending a EHAC accredited program:

- Eligibility to participate in the US Public Health Service (USPHS) sponsored FR COSTEP internship program.
- Exclusive access to valuable internships from: the **Centers for Disease Control's** (CDC) Summer Program in Environmental Health (SUPEH) and the **National Environmental Health Association's** (NEHA) National Environmental Public Health Internship Program (NEPHIP).
- Eligibility to compete for scholarships and internships provided by AEHAP and NSF International.

### Graduate Benefits of Attending a EHAC accredited school:

- Graduation from an accredited program is required to enter the US Public Health Service (USPHS) and US Army and Navy Environmental Science and Engineering careers.
- EHAC graduates meet the criteria to sit for the Registered Environmental Health Specialist /Registered Sanitarian (REHS/RS) exam upon graduation.
